

**PUBLIC NOTICE OF THE PUBLIC COMMENT MEETING ON
TUCSON ELECTRIC POWER COMPANY'S APPLICATION
FOR A PERMANENT RATE INCREASE
DOCKET NO. E-01933A-19-0028**

Summary

On April 1, 2019, Tucson Electric Power Company ("TEP") filed an application for a rate increase with the Arizona Corporation Commission ("Commission"). Commission Staff and Intervenor have filed separate recommendations. The Commission will issue a Decision regarding the application following consideration of testimony and evidence presented by all parties at an evidentiary hearing, which is set to begin on January 16, 2020.

The Commission is not bound by the proposals made by TEP, Staff, or any Intervenor.
